Our aims and purposes as a charity

- The purpose of our charity is to promote the Gospel of our Lord Jesus Christ according to the doctrines and practices of the Church of England, obeying Christ's two commandments 'You shall love the Lord your God with all your heart, and with all your soul, and with all your mind, and with all your strength ... You shall love your neighbour as yourself.' Mark 12.30-31a
- Our key aims are to:

We also hold services at All Saints Chapel and help to maintain it in a welcoming condition as a place of worship, in conjunction with the All-Saints' Chapel Trust.

What we planned to do to achieve our charitable objectives

When planning our activities for the year, our churchwarden and the PCC have considered the Charity Commission's guidance on public benefit and in particular, the specific guidance on 'charities for the advancement of religion'.

The council has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016, fully recognising its duty to have due regard to House of Bishops' guidance on safeguarding children and vulnerable adults.

Following the strategy of the 'Four More's' at the heart of the Chichester Diocesan Strategy 'Vision for Growth 2020-25', each of our parish aims has been identified in the context of being more open, more generous, more converted, and/or more engaged.

Aims and objectives for 2023

For 2023 the following objectives and activities were identified to fulfil our Mission Action Plan, linking as applicable to objectives from the four elements of the Chichester Diocesan Strategy 'Vision for Growth 2020-25'. They are formulated in an annual five-year planning meeting considering short- and long-term goals across all four areas of leadership, worship, community, and fabric, encompassing the spectrum of charitable purposes of our charity.

LEADERSHIP

Key Aim:

Manage parish affairs responsibly.

Context

Graffham with Woolavington is an active parish in Petworth Deanery in the Diocese of Chichester. At the beginning of the year Parish priest Revd Vivien Turner had been in post four and a half years. The Annual Vestry Meeting and Annual Parochial Church Meeting took place on 26 March 2023 when the electoral roll number was 69. Churchwarden Mrs Virginia Barrett continued as churchwarden. Including the priest in charge and two deanery synod members, the new PCC elected in 2023 has a complement of fourteen members, including

co-opted members Miss Beanie Bradley, Tower Captain Mr Howard Pescott and Safeguarding Officer Mrs Sonya Gillespie, ensuring our safeguarding responsibilities are fulfilled. Alongside a small but highly supportive congregation, and community supporters generous with both time and talents, these willing volunteers make possible the benefit which our charity offers for others.

The value of producing a Trustee Annual Report to record parish activity was highlighted by people who read the 2022 edition:

'I think this reads very well so congratulations... It's amazing that so much was achieved' — 'the TAR is a triumph...how much (we) do pack into our church year.' — it is heart-warming to read and reflect on all we achieved during 2022' — 'It certainly has been a year of great achievement' — "a wonderful reflection of a very busy year' — 'the result of great teamwork and excellent leadership.'

Aim: Initiate a project to develop our church vestry and interior for improved worship, hospitality, and community engagement: 'more open' and 'more engaged.'

The PCC five-year plan to improve church facilities by the end of 2026 highlighted a desire to improve church heating, consider installing toilet facilities and provide more appropriate hospitality facilities in St Giles Church. It also resolved to implement in full the recommendations in the quinquennial and bell-tower inspections conducted in late 2021 to the timescales recommended. Because of this, a number of developmental aims were put on hold during 2022 in favour of roof repair work essential to maintain the building fabric, considered of primary importance. This is described in the Fabric section of this report.

Aim: Consider succession planning for key roles within the parish to enable good continuity of service: 'more engaged'.

The five-year plan of the PCC also set out to take every step possible to maintain Graffham with Woolavington as a standalone parish with its own priest. In 2023, the extension of our present priest in charge's licence to the summer of 2026 provided some reassurance that all being well this continues to be a realistic possibility over the next few years. The importance of succession planning continues to be recognised by our parish whose small size makes recruiting capable and willing volunteers an ongoing challenge. We have kept this in the forefront of our minds to enable the best continuity and vitality of service here.

Aim: Continue to balance our budget: 'more generous.'

Maintaining parish financial security continued an important focus of attention in 2023. The Financial Statement following this report explains how the parish worked to fulfil the aim of balancing our budget this year. Our communication network continues to prove its worth in advertising our need for financial support to the community, eliciting a generous response.

WORSHIP

Context

Our church has long valued being open daily for villagers and visitors to the South Downs National Park, made possible through the kindness of a resident living nearby. Main Sunday Services

Including Parish Eucharist, BCP Matins, Holy Communion and Evensong.

In 2023 we have been cautiously encouraged by some improvement in numbers here. Wedding couples and their families have swelled our Sunday services on occasion, engaging in what it means to be married in a place of Christian community. We now offer a sparkling cool drink or warm mulled juice after Sunday Services, so all who attend can experience a hospitable welcome this way.

Cleaning

A dedicated group of church volunteers commit to maintaining the church in a welcoming condition. Through December, although much cleaning and tidying away of hay bales and props was necessary between school rehearsals and intervening church services, and especially following the animals' contribution to the Crib Service, it was all considered very much worth it by our church community.

Music - Little Choir, Festal Choir, Organists and New Hymn Books

We were sorry to lose our Ukrainian pianist in 2023 when she and her husband moved to a new home. We had benefitted from Tetiana's skill in playing and continue to pray for her wellbeing and for peace in her country. We received this message just before Christmas:

Congratulations on the upcoming holiday of the Nativity of Christ! We wish you good health, peaceful skies, love, and happiness. Our congratulations and best wishes to your parishioners... We remember with great pleasure and nostalgia the time spent with you. May your Guardian Angel always be with you.

Our little choir continued to contribute to our worship in 2023 and we enjoyed bringing the larger Festal Choir together, including community members, for special services, thanks to our enthusiastic organist Brian. It's good also to have a visiting organist Martin to play for occasional services. We have been delighted too, to welcome young soloists singing for the Coronation Service and Lessons and Carols respectively. New hymn books were purchased in 2023 to extend the repertoire of hymnody, including more music by contemporary liturgical composers, which have been much appreciated. 'The more I look into this hymn book, the more I realise what a good thing it is.' Email from choir member.

Bells

Our church bells call people to worship, voice community celebration and grief, host visiting teams and bring social benefit to a friendly and supportive band. In March 2023 our bell tower launched one bellringer's commitment to ring 50 bells in 50 towers to celebrate her 50th birthday, fundraise for the Sussex Association of Change-Ringers Bell Fund and raise enthusiasm for 'Ring for the King' ahead of the King's Coronation. Both BBC Radio Sussex and BBC TV South Today arrived to broadcast an event which caught the public imagination. Nominated by our parish, the Diocese of Chichester endorsed our valuation by awarding Mrs Vicky Chase the Order of St Richard for her contribution to bellringing in Sussex, at a special Evensong in September in the Cathedral, after which the cathedral bells responded joyfully.

Festival, Family and Special Services

Epiphany and Ordinary Time

Family Services in early 2023 followed various themes and used creative resources, including a wilderness brought into church for John the Baptist, and a 'seed swap' following the Parable of the Sower encouraging families to share resources and get planting.

Lent and Easter and Ascension

Services took place on Ash Wednesday and each day from Maundy Thursday to Easter Day. A house built from boxes on Mothering Sunday highlighted the caring that turns a house into a home. Donkeys arrived at church on Palm Sunday. Our foot-washing service employed the Maundy bowl and pitcher made by a local potter in 2020 featuring the imprints of parishioners' feet. All remained for the Watch of Prayer with a candlelit focus prepared by two congregation members. The Good Friday service followed the Stations of the Cross through the village from All Saints' Chapel to St Giles Church. Easter fire was lit at dawn on Easter Day, the Paschal candle was carried into church and the Exsultet sung. A well-attended Family Eucharist on Easter Day included an Easter Egg hunt in church. Ascension Day was celebrated with an early morning Eucharist outside in the churchyard.

Special Occasion - Coronation Thanksgiving Service 27 May

Following a year of Platinum Jubilee celebration and national grief following the death of Her Majesty Queen Elizabeth in 2022, Graffham stepped up to the plate once again with Coronation Celebrations for His Majesty King Charles III and Queen Camilla. Alongside a village picnic with celebratory cake at the recreation ground, a Coronation Thanksgiving Service, including the singing of Parry's 'I was glad' by the Festal choir was offered in a St Giles Church adorned with exceptional flower arrangements.

Bell Sunday

Having rung out in celebration of the King's Coronation, a new Service of thanksgiving for ringing was offered the following Sunday, with hymns celebrating ringing and the worthy contribution of our bellringers to the parish, under new Tower Captain Howard.

Animal Blessing

Another now-regular feature of the church calendar was the animal blessing service, held in July 2023 when nine dogs and one miniature pony were blessed.

Lammas, Harvest, St Luke's tide.

Lammastide was celebrated with a traditional home-baked Lammas loaf used for communion. Services during August were inspired by the Benedictine tradition. Our Harvest Service featured contributions from the Festal Choir, including 'Oats and Peas and Barley Grow' to the congregation's delight. This was followed by an enjoyable bring and share Harvest lunch, with donations to our local Foodbank. A healing Service with anointing was offered on the Sunday in October nearest to St Luke's Day.

Special occasion – All Saints' Dedication Festival

We marked the 70th anniversary of the dedication of All Saints Chapel on 29 October 2023 by transferring our Sunday Parish Eucharist to the Chapel, including the music of Eddye Loring, one of the chapel's original patrons, in the Service. The same evening, a spooky Halloween Service followed by guardian angel hunt was appreciated by the children who attended.

Remembrance

Playing a vital role in remembering those who served and suffered in demanding times, traditional observance of Remembrance took place in church and at the War Memorial. Wreaths were laid by the Chairs of both Graffham and, for a second year, East Lavington Parish Council, alongside those of the parish church and the village children. A new Service of Vigil and Lament on the eve of Remembrance Sunday provided opportunity to pray and reflect on war in our own time, following concern for people in Gaza and Ukraine.

Advent and Christmas

The Seaford College Chamber choir again sang at our Advent Service, bringing our local independent school and church community together in worship. A full programme of seasonal services in church included Lessons and Carols with Festal Choir, Quiet Advent Service with remembrance of loved ones, a record 150 people including 50 children attending our Christmas Eve Crib Service with goats and miniature pony in a tower 'stable', and a Christmas Day Eucharist. The flower arrangers surpassed themselves with floral decorations throughout the Christmas festival.

School services and Christmas plays.

Weekly assemblies continued in our Infant School in 2023, providing regular opportunity for worship and to get to know children in school and nursery. Each week the service is summarised in the school's 'Friday Flyer' newssheet, to include families in our worship taking place, and on our church Facebook page to include a wider audience. Harvest, Remembrance, Easter, and Christingle Services also took place, the last two in church with families attending.

Following a tragic car accident involving the death of the mother of a school family, an informal thanksgiving took place for children and families in the grounds of the school at which prayers were offered, bringing church and school together at a time of great sadness.

For a second year, the Infant School returned to church to offer their Nativity inspired by Strictly Come Dancing, with two performances and a contribution from the new Nursery. Our now regular end of school year Service thanked teachers, staff, parents, and children for contributing to school life. Once again, each child leaving school was given a holding cross and Lord's Prayer by St Giles Church to remind them of the school's Christian foundation.

Occasional offices

Baptism and Confirmation

There were no baptisms in the parish in 2023. However, we were delighted for the third time in five years to host a Deanery Confirmation in May 2023, presided over this time by Ruth Bushyager, Bishop of Horsham. It was an inspiration to our church community for three Graffham candidates and one Sutton candidate to confirm their faith, including the mother of a teenager confirmed in Graffham in 2022, a local shepherd, and a working mother of two.

We do so, facing the challenge of being church where the busyness of life and family commitments mean attendance is occasional rather than regular, though still includes a fair number of local people overall. We continued to engage the wider village community in special services, especially through attendance at Easter, Remembrance and Christmas; through participation in the Festal choir; through willingness to read Lessons occasionally; through provision of animals for Services; and through generous support of church events. St Giles Church and All Saints' chapel feel very much part of the whole village community, an integral feature of a rural church, and many value the church's presence here, providing confidence for the future.

Community Life

All the events described below build community life in our village in various ways, growing friendships as well as providing financial benefit for the church and other important causes.

Teddy Time: This small weekly group continues to provide opportunity for contact with parents and carers and a pleasant morning for young children, courtesy of the pavilion committee which offers this to us free of charge - a good example of church and community working together for everyone's benefit.

Social activities

Coffee mornings, tea afternoons and open garden teas continue to provide opportunities for new and long-standing residents to meet and socialise. In 2023, a Lent lunch in aid of the Christian Aid DEC Turkey-Syria Earthquake relief combined social engagement with serious reflection and the opportunity to donate in the wake of this tragedy. One coffee morning provided some funding for painting materials for our village school outdoor lavatory, also appreciated by our church congregation as required. Another raised funds for our church, as did an open garden in the beautiful surroundings of the South Downs. All were enjoyable occasions for everyone attending.

King Charles III Coronation Celebrations May

Following on from the significant royal occasions of 2022, it was a privilege to celebrate the coronation of our new monarch King Charles and his consort Queen Camilla, the details of which are described on page 7. Planning for these occasions being masterminded by our Worship and Community committees, both subgroups of our PCC.

Petworth Festival Concert July

Petworth Festival returned to St Giles Church for a second sell-out year, this time featuring the Osaka quartet. The delightful location of St Giles, excellent performance, good church acoustic and refreshments provided by our church contributed to an enjoyable afternoon for all attending. We are pleased to extend our service to the community in this way, the success of which has led to continuing requests to hold Petworth Arts Festival concerts here.

Graffham Fete August

Once again St Giles Church offered a 'Graffham Fashion Exchange' at the Village fete, bringing unwanted clothes for others to choose and take away, free of charge or for a voluntary donation. This is intended as an environmental initiative to encourage awareness of the hidden cost of buying new clothing for those who make them and for climate change. It was a popular stall once again.

Harvest Celebrations October

A celebratory Harvest Service was followed by a bring-and-share lunch in the Empire Hall, instead of shepherds' pies and crumbles made by volunteers in recent years. This proved a great success and raised a good amount for our local Petworth Foodbank.

Sponsored Walk October

This year's sponsored walk travelled from St Giles Church Graffham to Chichester Cathedral by a new route. A dozen walkers both from church and the wider community began in good weather and ended in rain, though it did not dampen convivial spirits and resulted in generous sponsorship being received for church funds.

'Food with Friends' November

Loneliness is a potential problem for everyone living alone. To guard against this, and for simple pleasure, a new initiative was started in 2023. A simple monthly shared lunch,

home-made soup, bread and cake, and fresh fruit is offered to village residents who live alone as an opportunity to meet and enjoy a social meal.

Christmas Fair December

Our traditional Christmas Fair took place again, with record results through the generosity of community members buying raffle tickets and produce etc, and donating to an extremely successful silent auction, to whom we are most thankful. After the fair, the Christmas tree was re-erected at the church to welcome everyone to Christmas Services.

White Horse Carols December

Once again, our church choir supported Carol Singing at a local public house before Christmas, with church organist accompanying and generous collection in aid of St Giles' church. Many local people attended and enjoyed the singing and delicious hospitality of the White Horse under a magnificent Christmas tree.

Lavington Park Federation Schools

In the first of two featured Community aims, our parish priest continues as Foundation Governor to our church school, leads weekly collective worship in the school hall and regularly visits the separate nursery school. The church facilitated building works at the school in 2023 by allowing builders to approach the site through our churchyard to avoid affecting the children. The location was respected, and areas of the churchyard were cleared with the workmen's help, proving a benefit to all. School events taking place in St Giles Church have been described on page 9, and we are delighted that they do so. We were delighted to welcome Seaford College choir once again to our Advent Service, and School children to help clean and tidy the church as part of the Seaford College Community Action Day.

Aim 2: Continue to strive to engage with important matters like poverty and environment; 'more engaged.'

Social and fundraising events described above show our church's engagement with many concerns, through the Lent lunch in aid of the Turkey-Syria earthquake appeal, coffee morning for the school outdoor lavatory, Fashion Exchange for environmental concern, Harvest lunch for the Petworth Foodbank and 'Food with Friends' for those who live alone. Petworth Area Churches Together to which our church belongs manages this Foodbank service, with a collection point now based at our village shop. In addition, the Seed Swap service allowed our churchwarden to raise funds for a Tanzanian orphanage, and 34 fruit crumbles were baked for the Stonepillow charity for homeless people, donated alongside food offered at our school's harvest services. The PCC has now voted to donate 10% of income, once costs have been met, to two designated charities in 2023, resulting in £400 donations each to the local Foodbank and Parish Support Work charity. Our Parish Priest Discretionary Fund continued to support school families in need amounting to almost £1000

We are glad to fulfil our mission in this parish in all these worthwhile ways, enabled through the energy and dedication of church members facilitating community life in this parish. We hope our service to others will inspire greater service and commitment to the whole of church life in this part of rural West Sussex, increasing faith and enabling ever more generous giving of time, talents, and resources in God's service.

Context

St Giles Church is situated within an open churchyard in the shelter of the South Downs with delightful views across the countryside and an open churchyard extension. The core of the church is medieval, though much rebuilt in the later nineteenth century in memory of Bishop Samuel Wilberforce. The main construction of the church is Fittleworth stone with walls faced in flint. The steepled church has a nineteenth century tower, containing six working bells.

Maintenance

Our practical maintenance schedule continues to prove its worth. Some who may not attend church services regularly show their willingness to support the church in this community, with village work-parties managing hedge-cutting and churchyard extension clearing and tidying. Maintenance issues completed in 2023 also include lychgate repairs, minor electrical works, and regular weeding and planting as part of our duty of care for those who use our building and churchyard.

Environment

With the guidance of Sussex Wildlife Trust, our mowing regime allows three areas to develop into wildflower meadows, providing havens for invertebrates and vertebrates. Our churchwarden also continues to regularly share environmental articles on the 'Greener Graffham' FaceBook page. She emphatically highlights urgency to bring about greater care of our planet, for which we continue to pray each Sunday.

Aims 1 & 2: Transferred to 2024.

Aim 3: Improve the churchyard area to enhance the church's surroundings: 'more engaged'.

Flagpole and Elizabeth II bench

Despite the limitations imposed by necessary roof work, progress was made in achieving this aim. Through the generosity of Mrs Bumble Findlay, a flagpole was erected in our churchyard in memory of her husband Gordon, complete with Union and Chichester Diocesan flags. A bench was also gifted to the church from the David Laing Foundation, in memory of Queen Elizabeth II and the donor's grandfather Sir John Laing. Queen Elizabeth's faithful service and Sir John's commitment to faith and prayer in a time of trial makes this bench particularly valuable to our church. We thank both donors for enhancing our churchyard in these ways.

Aims and objectives for 2024

For 2024 the following objectives and activities have been identified to fulfil our Mission Action Plan, linking to objectives from the four elements of the Chichester Diocesan Strategy 'Vision for Growth 2020-25' as applicable. These are formulated in an annual five-year planning meeting considering short- and long-term goals across all four areas of leadership, worship, community, and fabric, encompassing the spectrum of charitable purposes of our charity.

Leadership

- 1 Affirm and promote single parish ministry as a valuable model of ministry for the future of the Church of England: 'more open.'
- 2 Develop succession plans for key roles in the parish for good continuity of service: 'more engaged.'

Annual Financial Report for the year ended December 31st, 2023.

The Financial Review

Summary

The Church's total income across all funds in 2023 was £68,356 (2022: £84,277), with costs of £55,164 (2022: £67,932). Unrestricted income totaled £64,652 (2022: £64,210) and expenditure totaled £50,194 (2022: £50,329). Included in the income is the net proceeds from the 2023 Christmas Fair of £9,138 (2022: £5,416) which has been retained in the general fund. The surplus for the general fund, which covers all day to day running expenses of the Church, was £14,458 (2022: £13,881).

Throughout 2023, the PCC has continued to successfully focus on the need to increase unrestricted income to enable all its day-to-day expenditure to be met, as well as to allow provision for identified maintenance and repair costs. In 2021 a designated fund was established which has been increased following the surplus in income again this year. During 2024 the aim is for general fund income to at least match general fund expenditure with specific fund raising for any identified planned specific projects and purposes.

The value of the investment funds has increased by £4,008 (2022: loss £5,741). Overall funds have increased by £17,200 (2022: £10,604) to £119,967 (2022: £102,767).

A full breakdown is provided in the financial statements.

Rectory Costs

The running costs of the Rectory attributable to the Parish amounted to £3,984 (2022: £3,780) which included council tax and water charges. There was no expenditure incurred by the PCC on maintenance of the building.

Giving

Unrestricted giving received by the PCC (excluding Gift Aid reclaimed and legacies) this year was £31,257 (2022: £33,745). Restricted funds received £1,036 (2022: £19,567) plus the LPOW grant of £2,089 (2022: charitable grant £5,000).

The facility to give online via the Give a Little facility was launched in the second half of 2020. It has proved to be a useful and helpful avenue to aid one-off giving for those who prefer not to donate on a regular basis. Promotion is via the website and information "post cards" distributed during church services and local events.

In the last quarter of 2021, the PCC signed up with the EasyFundraising initiative. There has been a reasonable increase in take up amongst the community, and it is planned to "re-launch" this initiative in the community in 2024 to encourage more parishioners to engage with this initiative. The total received during the year is £217 (2022: £229).

Regrettably the Goodbox facility has been out of use for most of the year as a replacement device has been unavailable. Various other options for card giving have been explored but these have shown to be expensive and inoperable in the church due to the weak mobile signal and lack of adequate internet connectivity. The Goodbox option will be explored again in 2024.

A very few parishioners prefer to continue their regular giving by standing order and while every effort has been made to encourage these folk to switch to giving via the Parish Giving Scheme (PGS), the PCC recognize their preferences. Ongoing efforts and regular communications via the Parish Magazine, at church services and local parish events aim to seek new donors to contribute through the scheme. The total for the year was £15,895 (2022 £15,678).

During most of the year we have run a variety of fundraising events and are pleased to report total income from these sources of £2,410 (2022: £ 3,038) for the general fund.

Bank accounts

The Nat West account remains open for the collection of donations from those people who, for a variety of reasons, have chosen not to transfer to the Parish Giving Scheme. The Barclays account receives all other income and is used for all expenditure.

Diocesan Contribution

The largest item of expenditure was the parish contribution to the Diocese of Chichester of £26,656 (2022: £30,724) being fulfilment of a 100% pledge, representing full contribution of our costs. In 2024 the PCC expects to honor its pledge to contribute once again 100% of its parish ministry costs.

Insurance

The PCC's insurance provider is Trinitas. There have been no claims during the period and the PCC have agreed to renew the policy with this company when it falls due in January 2024.

Quinquennial Report

The inspection took place in December 2021 and the full report was provided to the PCC in January 2022.

Whilst the rate of deterioration in a building such as St Giles is unpredictable the 2021 Quinquennial Inspection Report did not identify any major problems. It did however note that a proper inspection of the Chancel roof had not taken place. There has also been some ingress of water on stormy days. At the end of the year repair work began and remains ongoing as does further investigative work. The roof is to be made watertight as a priority for 2024.

All the other comments within the report and which relate to annual maintenance have been addressed. The PCC anticipates being able to meet ongoing scheduled repair and maintenance costs associated with the Report over the next five years, from its Fabric fund or if necessary, the Designated Fund reserves.

The bell bearings are some 40 years old and will need replacing within three to five years at an approximate cost of £6,500 plus VAT. Additionally the wheels to the largest four bells will need to be rebuilt within the next five years at an estimated cost of £11,000 plus VAT.

Charitable Giving

During the year the PCC made donations totaling £2,831, including £560 to the Petworth Food Bank, £612 for the Turkey Syria Earthquake Appeal, £170 to the British Legion, £667 to the Deanery's Family Support Work, and a total of £1,027 from the Parish Priest's Discretionary Fund to help families in need within the parish.

Donations via the PPDF

We are pleased to report the continuation of this restricted fund. The purpose of the fund is to assist local families in need, as recommended to the Parish Priest. The PCC have been able to gift £1,027 during the year in support of families within the parish with further support identified to be made early in 2024.

Reserves Policy

The restricted Fabric fund remains to cover the cost of works which are required following the quinquennial inspection and additionally from time to time as may be identified. At year end the balance held in the restricted fabric fund was £6,409 (2022: £8,942). There has been £2,583 of expenditure incurred during the year from this fund.

The PCC's financial policy makes allowance for the general fund balance to be of the order of £20,000 which covers almost six months expenditure (based on 2023 costs). As such a surplus of £19,000 from the general fund has been transferred to the designated fund. At year end the General Fund contained a sum of £22,233. The Designated Fund balance is £59,000.

Notes to the Financial Statements

The financial statements of the PCC have been prepared in accordance with the Charities Act 2011 and current Church Accounting Regulations, using the Receipts and Payments basis.

The following assets are recognized but not valued in the Statement of Assets and Liabilities: movable church furnishings held by the churchwardens on special trust for the PCC, which require a faculty for disposal.

Investments

In addition to the bank accounts held with Barclays and Nat West, there are four further accounts.

The CCLA deposit account balance at 31st December was £38,882 (2022: £17,586) and interest of £1,295 was received and applied to the general fund.

The CCLA Investment fund holds 1159.02 shares whose value at 31st December was £26,200 (2022: £23,947). The income received is applied to the general fund.

The Nudd fund, an endowment fund, holds 715.39 shares whose value on 31st December was £16,177 (2022: £14,836). Income received from this fund was £442 and is restricted to the garden fund. This fund is held on behalf of the PCC by the Diocese of Chichester.

The Brandt fund, an endowment fund, holds 221.93 shares whose value on 30th December 2023 was £5,016 (2022: £4,602) Income received from this fund was £137 and is restricted to the garden fund. This fund is held on behalf of the PCC by the Diocese of Chichester.

Statement of Funds

Unrestricted General Fund:

This fund is unrestricted and is used to record both unrestricted income and expenditure.

Designated Fund:

The PCC established a designated fund at the end of 2021 by transfer of £30,000 from the general fund. The PCC wishes to adopt a prudent approach by ensuring sufficient liquidity is available to meet planned and unforeseen costs and has agreed to increase the designated fund by £19,000 from surplus income during 2023.

The early January 2023 a five-year plan was put in place which included ensuring funds were available to meet urgent and immediate expenses and costs as identified in the quinquennial report for the bells and the works to the graveyard extension to facilitate additional burial spaces. During the year, these works have been undertaken with the cost met from the various restricted funds. Repairs to the organ have been covered following generous donations from a parishioner which meant a small level of expenditure from the general fund.

The five-year plan will be reviewed and updated in January 2024. The main focus during the early part of the year will be to complete the repairs to the roof. A budget for this work has been agreed at £32,000, which includes both VAT and a contingency. A number of grant applications to obtain half of this sum are in course and the VAT should be recovered under the LPOW scheme. Against this forecast the PCC conclude adequate funds will be available to cover the roof repairs and once these have been completed an assessment can be made to undertake additional renovations to the inside of the church (including repair to plaster and redecoration).

Additionally, there is a desire to improve lighting and paths to the Church, repair the boundary wall, install a sound system, and commission a survey to identify the possibility of installing a WC. There is also a desire to supplement the Pew Cushion Heating systems with a sustainable heat source.

On this basis the PCC consider a good portion of the available money within the designated fund and the fabric fund will be fully utilized at some point in the near future; it is considered suitable to maintain a sufficient amount to cover any unforeseen expenditure.

Restricted Funds:

The Pew Cushion Heating (PCH) Fund: This fund was established in 2022 following very generous donations from parishioners totaling just over £ 7,000 (plus gift aid where applicable) to contribute towards the cost of the installation of PCH. Following a successful application, the PCC also benefited from a grant of £5,000 from a registered charity to assist with this project. The heating system was installed in November 2022 and is proving both effective and cost efficient. A LPOW grant application was made in 2023 to recover the VAT element of £2,089. This was received and this will be applied to the PCH fund to assist with energy costs for the future. The total cost of the Pew Cushion Installation (ex VAT) was £ 10,445 which was totally funded from donations and grants. The balance at 31 December 2024 is £1,385.

The Garden Fund: This fund receives the income from the Nudd (Endowment) Fund, and the Brandt (Endowment Fund), along with any other donations to gardening and cemetery maintenance. The fund contains a balance of £1,724 on 31st December.

The Bell Fund: This fund received donations during the year amounted to £627 and we carry a total at the end of the year of £5,106 after costs of £14 for maintenance during the year. It is anticipated this fund will increase during 2024 as fundraising initiatives help to build resources to cover future major works. The balance at 31 December 2024 is £5,106.

The Organ Fund: During the year, the Organ Fund received donations of £360 which covered the expenditure on repairs and maintenance. The balance at 31 December 2024 is £422.

Fabric Fund: Expenditure from this fund was £2,583 and the closing balance is £6,409. This fund will be used to cover ongoing repair and maintenance costs as well as the program of works as identified in the quinquennial report. The balance at 31 December 2024 is £6,409.

Parish Priest Discretionary Fund: Established in July 2020. Gifts in support of local families in need totaled £1,026 during the year. The closing balance is £2,495.

Endowment Funds:

The Nudd Fund (a restricted capital fund) is invested in the CBF C of E Investment Fund and held by the Diocese on our behalf. The income continues to be paid to the Garden Fund which is used for the maintenance of the graveyard extension.

The Brandt Fund (a restricted capital fund) is invested in the CBF C of E Investment Fund and held by the Diocese on our behalf. The income is attributed to the Garden Fund which is used for the maintenance of the graveyard extension.
